Add the following note which applies to Part A and Part B:

ASBESTOS INSPECTION

AN ASBESTOS CONTAINING MATERIALS (ACM) INSPECTION OF ALL BUILDINGS SCHEDULED FOR DEMOLITION WITHIN THE PROJECT SHALL BE COMPLETED BY A CERTIFIED ASBESTOS HAZARD EVALUATION SPECIALIST (CAHES) PRIOR TO ANY DEMOLITION ACTIVITIES TO DETERMINE THE PRESENCE AND QUANTITY OF ASBESTOS CONTAINING MATERIALS.

ASBESTOS TESTING FOR EACH PARCEL SHALL NOT OCCUR UNTIL PROPERTY OWNERS HAVE BEEN RELOCATED. SEE THE PROPERTY ACCESS NOTE IN THE GENERAL NOTES FOR DETAILS.

AT THIS TIME, ODOT HAS NO INDICATION THAT ASBESTOS IS PRESENT WITHIN THE BUILDINGS. IF THE INSPECTION RESULTS INDICATE ASBESTOS IS PRESENT, ABATEMENT WORK SHALL BE REQUIRED PRIOR TO DEMOLITION, AND WILL BE ADDRESSED IN ACCORDANCE WITH CMS 109.05.

THE CONTRACTOR SHALL FURNISH ALL LABOR (INCLUDING A CERTIFIED ASBESTOS HAZARD EVALUATION SPECIALIST), EQUIPMENT, MATERIALS, AND INCIDENTALS NECESSARY TO COMPLETE THE INSPECTIONS. PAYMENT FOR THIS WORK SHALL BE MADE AT THE CONTRACT PRICE BID, EACH. THE FOLLOWING QUANTITIES HAVE BEEN INCLUDED IN THE GENERAL SUMMARY FOR THE WORK NOTED ABOVE:
